

Higher Education Emergency Relief Fund Report – Emergency Financial Aid Grants to Students

Quarterly Reporting – Distribution as of December 31, 2021

Under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Coronanaviris Response and Relief Supplemental Appropriations Act (CRRSAA) and AmericanRescue Plan Act (ARP) signed into law, Higher Education Emergency Relief Fund (HEERF I, II & III)), Platt College Los Angeles, LLC¹, campuses locations Alhambra, Anaheim, Ontario and Riverside, received education stabilization funds designated exclusively for emergency financial aid grants to students.

Pursuant to guidance issued by the Department of Education through an [Electronic Announcement](#) published on May 6, 2020, we are providing the following information about the funds we have received, and how, and to whom, we have distributed them.

1. On April 17, 2020, the institution signed and returned to the Department the ***Recipient's Funding Certification and Agreement (for) Emergency Financial Aid Grants to Students*** required to receive funds allocated under Section 18004(a)(1) of the CARES Act. The institution has used, or intends to use, no less than 50 percent of the total funds received to provide emergency financial aid grants to students.
On April 15, 2021, the institution signed and returned to the Department the ***Certification and Agreement*** required to receive funds allocated under section 314(a)(1) CRRSAA. As required, the institution intends to use 100 percent of the total funds received to provide emergency financial aid grants to students.
On August 11, 2021, the institution signed and returned to the Department the ***Required Proprietary Institution Certification Form*** required to receive funds allocated under section 2003(a)(4) ARP. As required, the institution intends to use 100 percent of the total funds received to provide emergency financial aid grants to students.
2. The total amount of funds that the institution has received from the Department pursuant to the institution's Certification and Agreement specifically for emergency financial aid grants to students is:
 - \$1,665,047 – CARES Act under section 18004(a)(1)
 - \$2,250,857 – CRRSAA under section 314(a)(1)
 - \$1,358,809 – ARP under section 2003(a)(4)
3. The total amount of emergency financial aid grants distributed to students under CRRSAA section 314(a)(1) and ARP section 2003(a)(4) as of the date of this Fund Report is \$3,609,666.
4. The estimated total number of students at the institution potentially qualified to receive emergency financial aid grants under CRRSAA section 314(a)(1) and ARP section 2003(a)(4) as of the date of this Fund Report is 1577.

5. The total number of students who have received an emergency financial aid grant under CRRSAA section 314(a)(1) and ARP section 2003(a)(4) as of the date of this Fund Report is 1216.
6. The methods we used to determine which students receive emergency financial aid grants and how much they would receive of the CARES Act under Section 18004(a)(1), CRRSAA section 314(a)(1) and ARP section 2003(a)(4) are included below under “Student Emergency Funding Allocation”.
7. The information we provided to students concerning the emergency financial aid grants appear below under “Student Notices”.

Student Emergency Funding Allocation

CARES Act under Section 18004(a)(1):

Platt College Los Angeles, LLC made its first distribution of CARES Act emergency grant funds to students on May 26, 2020 using the following methodology:

- Students with high degree of financial need, as reflected in their eligibility for Federal Pell Grant funds and their primary EFC (expected family contribution). The award amount was based on the reported primary EFC of each student’s most recent 2019/2020 ISIR (Institutional Student Information Records) as of May 11, 2020.
 - EFC 0 received \$1,350.00
 - EFC 1-999 received \$1,200.00
 - EFC 1000-1999 received \$1,100.00
 - EFC 2000-2999 received \$1,000.00
 - EFC 3000-3999 received \$ 900.00
 - EFC 4000-4999 received \$ 800.00
 - EFC 5000-5576 received \$ 700.00
- Military Veteran students who were granted an approved Leave of Absence due to COVID-19 related campus disruption that resulted in the unavailability of certain courses offered through remote learning, and whom experienced a loss in military housing benefits from the Veteran’s Administration due to that disruption.
 - Veteran students were provided \$6,195.00 in grant aid to offset the loss of VA housing allowance funds.

Platt College Los Angeles, LLC made its second distribution of CARES Act emergency grant funds on July 9, 2020 to students through an application process using the following methodology:

- Title IV eligible students who did not qualify for the first round of grants(outlined above) because they were not eligible for Pell Grant, were provided the opportunity to apply for available funds. Students submitted an application which included an attestation to

having incurred expenses due to disruptions to campus operations caused by the Coronavirus pandemic.

- If the student met the application requirements, s/he was provided an emergency grant of \$600.00.

Platt College Los Angeles, LLC made its third distribution of CARES Act emergency grant funds on August 26, 2020 to students using the following methodology:

- Students with high degree of financial need, as reflected in their eligibility for Federal Pell Grant funds and their primary EFC (expected family contribution). The award amount was based on the reported primary EFC of each student's most recent 2019/2020 ISIR (Institutional Student Information Records) as of May 11, 2020.
- Students with a primary EFC (expected family contribution) of \$0 (zero) was provided an additional emergency grant of \$154.00.

CRRSAA section 314(a)(1) and ARP section 2003(a)(4):

Institutions participating in the Higher Education Emergency Relief Fund grant programs have the responsibility of determining how grants will be distributed to students based on the statutory mandate that the institution prioritize students with exceptional need. Institutions must also develop a procedure to establish the amount of each student grant communication and instructions provided to students about the grant.

Platt College's total allocated funds under HEERF II & III was \$3,609,666:

- \$2,250,857 - HEERF II Allocations for Platt College under CRRSAA section 314(a)(1)
- \$1,358,809 - HEERF III Allocations for Platt College under ARP section 2003(a)(4)

To determine the eligible population of students and the amount of each grant, Platt College Los Angeles, LLC evaluated the degree of financial need of the entire student cohort during the funding period. Exceptional need was based on the reported primary EFC (expected family contribution) of each student's completed FAFSA and receipt of 2020/2021 and/or 2021/2022 ISIR (Institutional Student Information Records).

Planned Funding Allocation and Distribution:

November 2021 - 80% of funds (approx. \$2,887,200):

Awards will be prioritized to eligible students who met the following criteria:

- Actively enrolled as of September 28, 2021
- Students with a \$0 (zero) EFC as reported on their 2020/2021 and/or 2021/2022 ISIR

Student population = 800 students, award approximately \$3609 each student

UPDATED December 16, 2021:

Student population = 802 students, award approximately \$3609 each student

November/December 2021 - 20% of funds (approx. \$722,466):

1. Awards will be prioritized to eligible students who met the following criteria:
 - Actively enrolled as of September 28, 2021
 - Students with a valid EFC range on their 2020/2021 and/or 2021/2022 ISIR (Pell eligible range used):
 - o 2020-21 ISIR - EFC range between \$1 - \$5711
 - o 2021-22 ISIR - EFC range between \$1 - \$5846

Student population with eligible EFC = 411, award approximately \$1757* each student

UPDATED December 16, 2021:

Student population with eligible EFC = 414, award approximately \$1727.66* each student

2. Students with no ISIR on file will have an opportunity to complete a FAFSA at <https://studentaid.gov/h/apply-for-aid/fafsa>. Deadline date to apply will be determined. Notification letter will be emailed and/or mailed to these students.

- Student population with no ISIR on file = 104 (50 Distance Education & 54 all other), award amount to be determined *
 - o Zero EFC will be awarded \$3609
 - o Pell eligible EFC range award amount to be determined*

UPDATED December 16, 2021:

Student population with no ISIR on file = 97

**Award amount will be determined once all ISIR's have been received by the determined deadline to submit a FAFSA.*

Other notes:

Students will only be eligible to receive one emergency grant under the Platt College CRRSAA/ARP Grant program.
